An experienced occupational therapist/case manager can help you navigate through this very distressing time. We will support and guide you, help you cope, and enable you to gain control of your life. We aim to restore your hope and encourage you to make plans for the future.

We will work with you to assist you with every aspect of your rehabilitation, which includes your medical needs, housing adaptations, equipment, care and need for emotional support. Through the most challenging of times we endeavor to build trust and understanding and encourage teamwork among all involved. Our occupational therapists/case managers understand that when the worst happens it touches not only the injured person but those who are closest to them; their families and friends. We will do all we can to support you and your family.
