### Biography

Since graduating in 1979, Clare has worked within the statutory, educational and independent sectors, working with people with a wide range of physical disabilities. She has extensive casework, management, organisational and supervisory experience.

For a significant period of time, Clare has concentrated on working with clients who have suffered severe and complex injuries including acquired brain injury, amputations and complex orthopaedic injuries. This has involved detailed collaboration with the client and their families, their representatives, and statutory and private providers.

She has extended her case management skills in working specifically with children and young people with a range of conditions but particularly traumatic brain injury.

Clare completed a master's degree (Msc) in Rehabilitation (neurological pathway) in 2014 and was awarded a distinction for her research and for the MSc overall.

She continues to expand and develop her practice and her consultancy work within statutory services ensures she is up to date with policy and practice in a wider context. This work has included an ongoing role with a statutory housing provider, and the training and professional supervision of staff.
