After qualifying in 1994, Deborah had considerable experience of working for the NHS, before changing focus and moving to work within the private insurance and personal injury claims sector in 2012.


She manages a wide-ranging caseload with referrals from a variety of sources including insurance companies, solicitors, employers and medical consultants.


