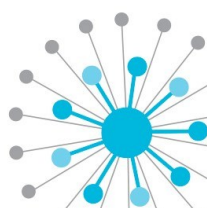

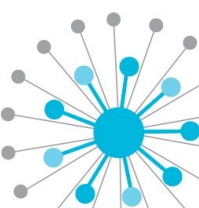

## Clinical skills and experience

- Clients have included those with neurological conditions such as mild brain injury and post-concussion syndrome, stroke, Parkinson's disease, multiple sclerosis and Guillain Barre syndrome. They have also had a variety of orthopaedic conditions, including upper and lower limb and spinal cord injuries, brachial plexus lesions and amputations.
- Provided hand therapy for rheumatoid patients and carried out pulmonary and cardiac rehabilitation programmes.
- Interventions have included managing physical and psychological rehabilitation, delivery of post-concussion syndrome OT rehab programmes, assessment and advice on adaptations both at home and in the workplace, equipment recommendation and provision, the development and delivery of multi-disciplinary group interventions (such as pulmonary and cardiac rehabilitation) and monitoring graded return to work programmes.
- Works closely with consultants, general medical practitioners, health and social care professionals (nursing/physiotherapy/speech and language therapist/dieticians/podiatrists), social workers, case co-ordinators, psychologists and the voluntary sector.
- Training provision for health, adult social care employees and private home care on rehabilitation and goal setting, appropriate moving and handling of patients in the community, safe use of equipment and provision and managing risk.
- Management of own independent practice.
- Previous roles have included therapy team leader for the Early Intervention Service and team leader of a multi-disciplinary older adult specialist day hospital with 13 staff members.
