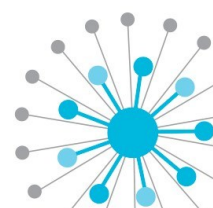
She supports clients from the early assessment stage through to acquiring appropriate high level specialist equipment, therapy, transport, accommodation and care packages.

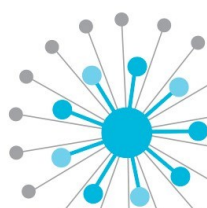

Career history - private sector

Independent Occupational Therapist & Case Manager - Independence Works Ltd 2021 - present

- Provision of occupational therapy case management for clients following personal injury, working under both joint and single instruction under the 2015 Rehabilitation Code.
- Undertaking comprehensive assessment of rehabilitation and treatment needs, preparation of detailed rehabilitation reports with a focus on occupational performance and client goals, prompt and timely implementation of rehabilitation programmes.
- Working with clients, their families and carers, developing/effectively managing multidisciplinary teams to deliver high quality rehabilitation programmes.

Senior Associate Occupational Therapist - CJ Occupational Therapy 2017 - 2021

- Community based intervention in the private sector for clients with an acquired brain injury.
- Intervention included working within a client's own home environment, supported living accommodation, community based activities and leisure interests in order to optimise independence.

Career history - statutory sector

Band 6 OT, Spinal Cord Injury Rehabilitation Centre, Rookwood Hospital, Cardiff 2007 - 2021

- Caseload predominantly consisted of spinal cord injured clients, however experience also gained with conditions such as Devic's disease, transverse myelitis, peripheral neuropathy and polytrauma.
- Caseload required significant rehabilitation intervention including postural management, upper limb therapy, including tenodesis management, powered mobility, access to assistive technology and major adaptations as well as continuing health care assessment.
- Presented to the patient education programme (SCIP) re: pressure and skin management.
- Other responsibilities included managing the wheelchair resources and equipment safety management and the supervision of junior staff and assistants as well as other members of the spinal injury unit.

Band 6 OT, Neuro Rehabilitation Rotation, Rookwood Hospital, Cardiff 2006 - 2007

- Rotational role providing rehabilitation to clients with acquired and traumatic brain injury.
- Provided comprehensive specialist neurological OT assessment and intervention for activities of daily living, wheelchairs, seating, upper limb management and complex discharge planning.
- Diagnoses included subarachnoid haemorrhages, brain stem stroke and locked-in syndrome.

Band 6 OT, Acute Neuro Services, University Hospital of Wales, Cardiff 2005 - 2006

- Rotational role included input to wards and intensive care, with specific intervention for clients with complex traumatic and non-traumatic spinal diagnoses, including graded exposure from bed to sitting.
- Neurological OT assessment and intervention for activities of daily living, equipment needs, upper limb rehab, splinting and discharge planning.
